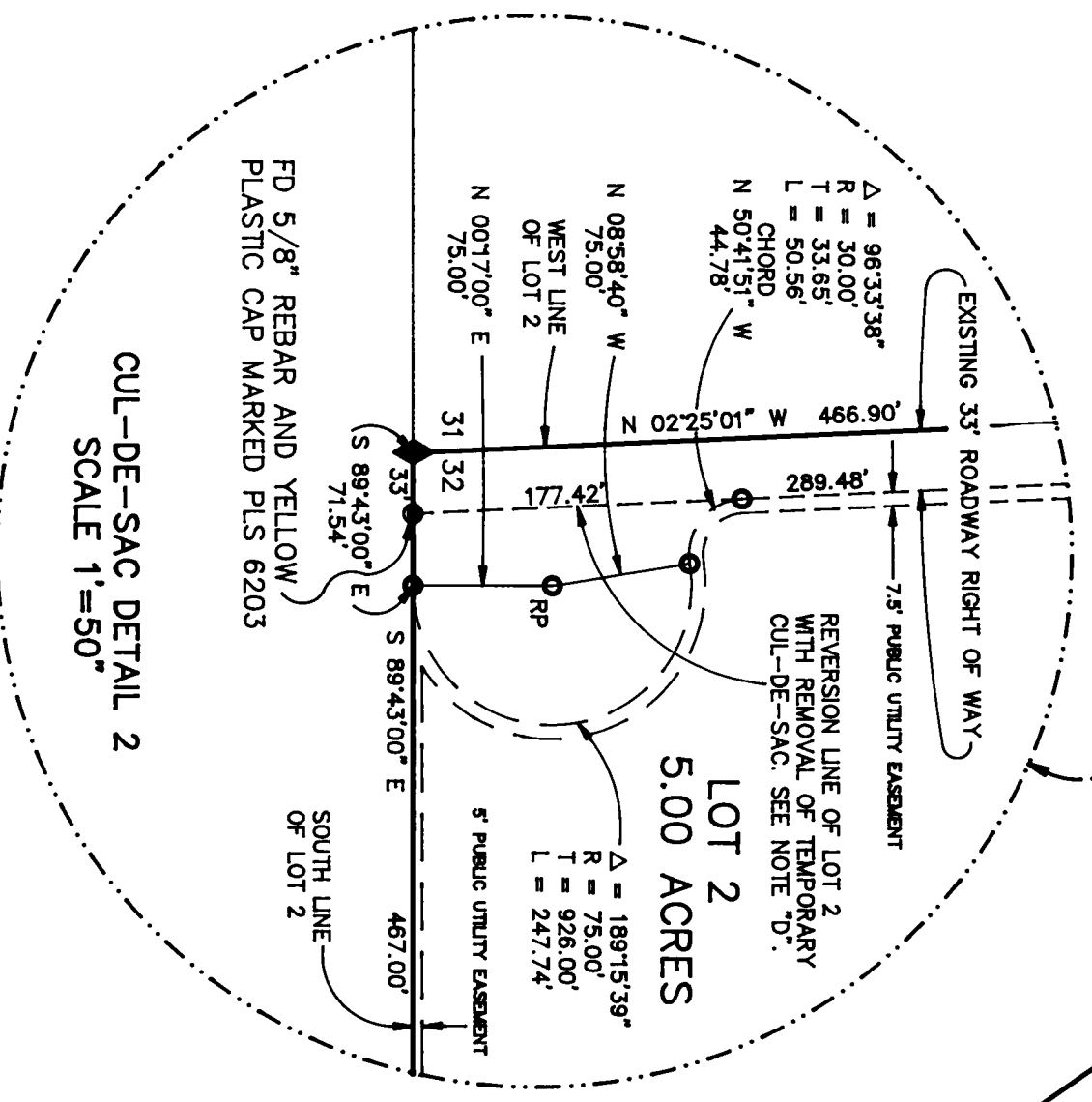
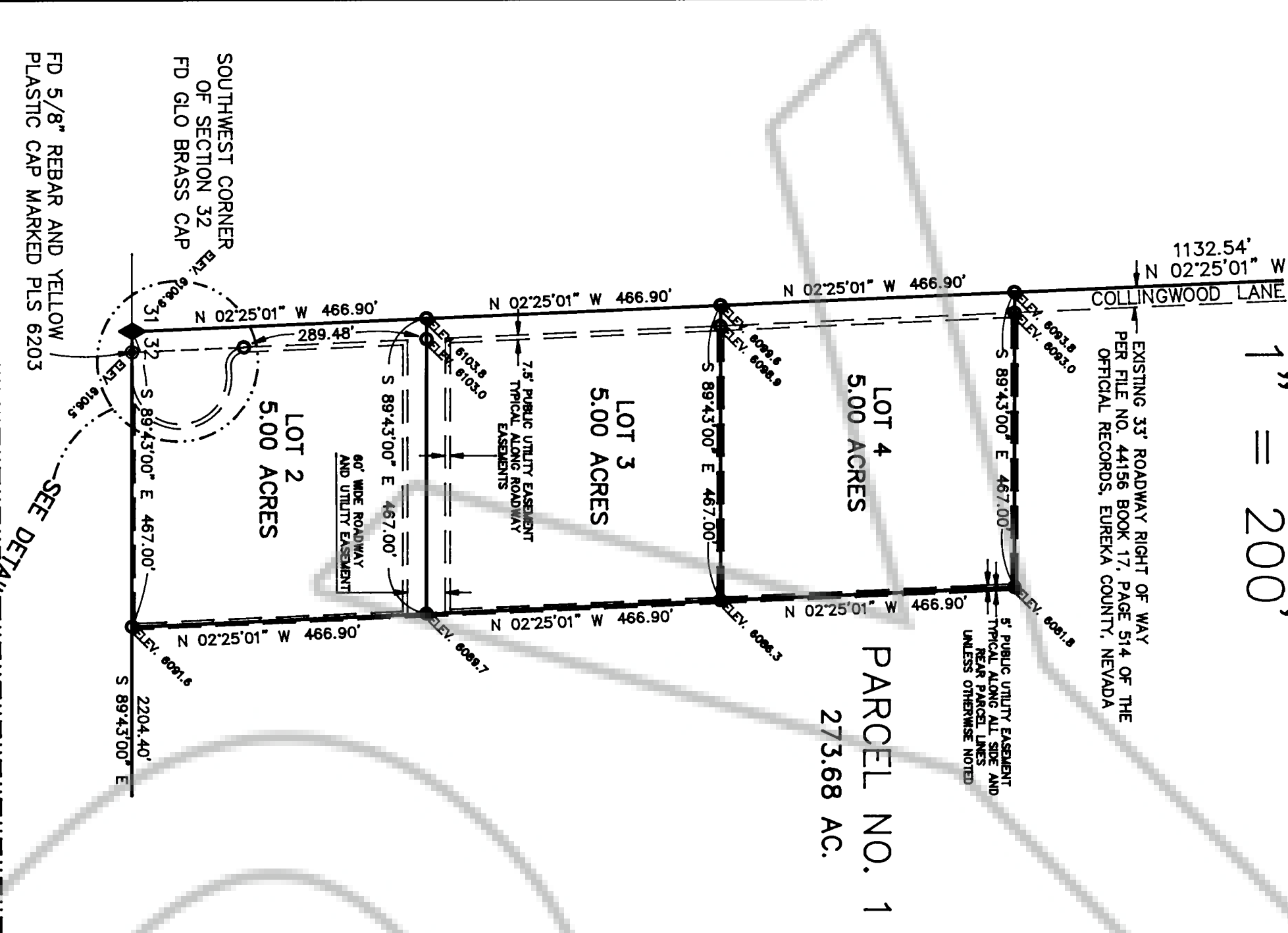

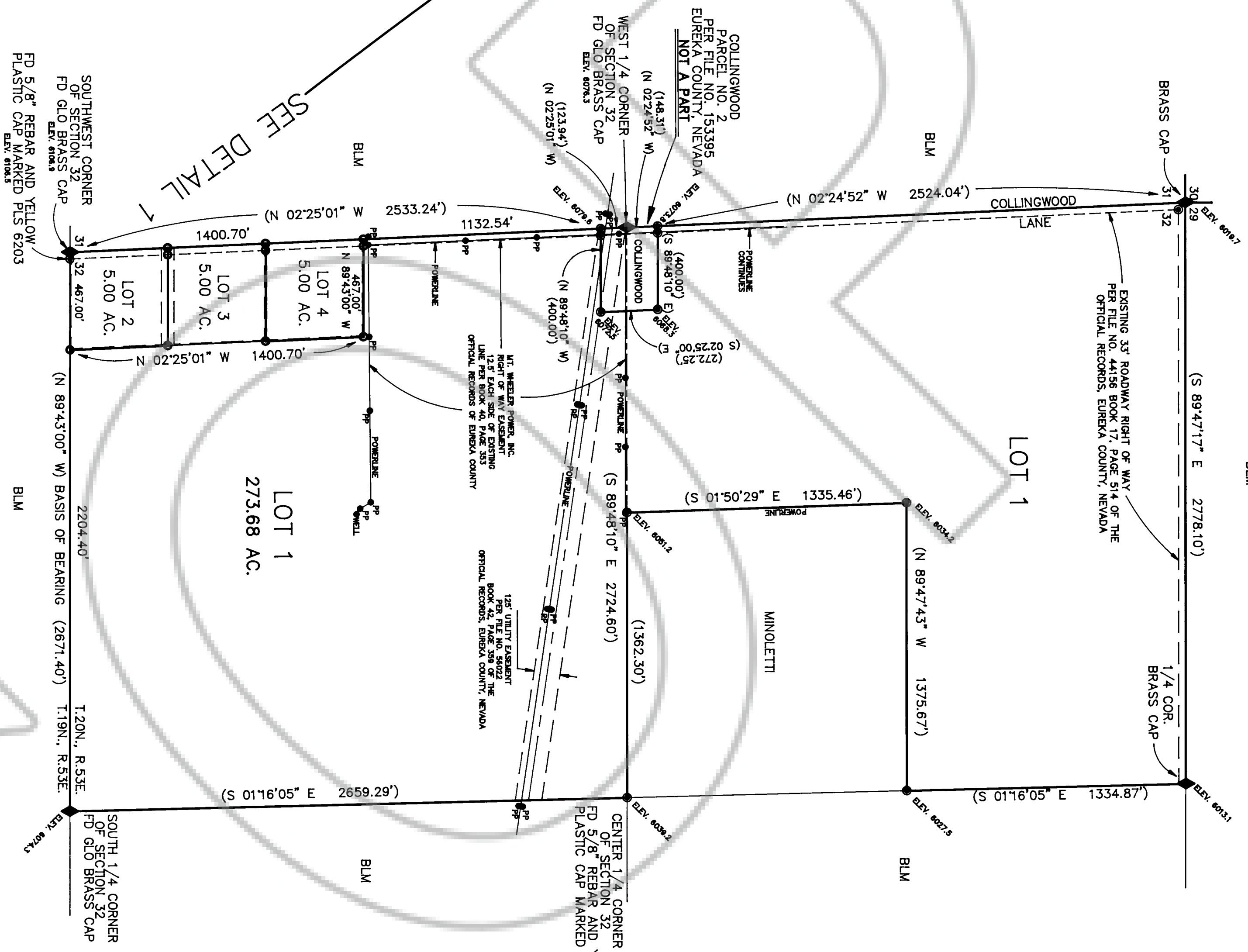
SURVEYOR'S CERTIFICATE

 2. THE LANDS SURVEYED LIE WITHIN SECTION 32, T.20N., R.53E., M.D.M., AND THE SURVEY WAS COMPLETED ON AUGUST 1, 1996;
 3. THIS PLAT COMPLES WITH THE APPLICABLE STATE STATUTES AND ANY LOCAL ORDINANCES IN EFFECT ON THE DATE THAT THE GOVERNING BODY GAVE ITS FINAL APPROVAL;
 4. THE MONUMENTS DEPICTED ON THE PLAT ARE OF THE CHARACTER SHOWN, OCCUPY THE POSITIONS INDICATED AND ARE OF SUFFICIENT NUMBER AND DURABILITY.

- A) PUBLIC UTILITY EASEMENTS HEREBY RESERVED ARE 7.5' ADJACENT TO ALL ROADWAY EASEMENTS AND 5.0' ADJACENT TO ALL OTHER 5 ACRE PARCEL LINES.
- B) FURTHER PARCELING OF ANY PARCEL CREATED BY THIS MAP MAY BE SUBJECT TO THE PROVISIONS OF NRS 278.462.3 PERMITTING IMPOSITION OF REASONABLE IMPROVEMENT STANDARDS, BUT NOT GREATER THAN REQUIRED FOR SUBDIVISIONS.

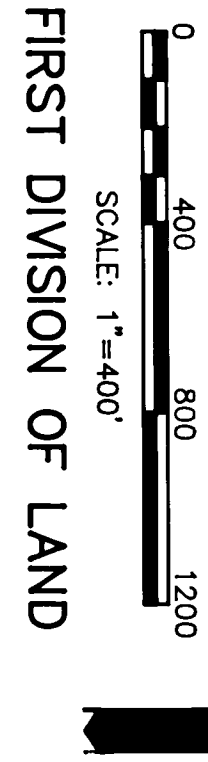
