The Claim is approximately 1500 feet long and 600 feet wide, such that 20 feet are claimed in a North direction and 1480 in a South direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the Claim. The general course of the lode or vein is from the North to the South direction.

Beginning at the NE corner (Cor. No. 1), thence 1500 feet south to the SE Corner (Cor. No. 2), thence 600 feet west to the SW Corner (Cor. No. 3), thence 1500 feet north to the NW Corner (Cor. No. 4), thence 600 feet east to the Point of Beginning.

Said claim is a lode it being situated in the above mentioned county and state, and it is distinctly marked on the ground so that its boundaries may be readily traced by four 2" x 2" wooden post four feet long. Each monument is marked with a scribed metal tag, which states the claim name and number, and the location of the monument with respect to the claim.
