MEMORANDUM OF LEASE/AMENDMENT

THIS MEMORANDUM OF LEASE/AMENDMENT is made as of the / St day of SEPTEMBER 1996 by ROBERT L. FARLEY and GEORGIA LYNN PARLEY, husband and wife, of 4916 Allamar Drive, Boise, Idaho 83704, CARL A. FARLEY and DONNA L. FARLEY, husband and wife, of 3747 Siphon Drive, Ontario, Oregon 97914 (collectively the "Farleys"), on the one hand, and BARRICK GOLDSTRIKE MINES INC., & Colorado corporation, whose address is P.O. Box 29, Elko, Nevada 89803 ("Barrick") and GOLD VENTURES, INC., a Nevada corporation, whose address is P.O. Box 2008, Elko, Nevada 89803 ("Gold Ventures").

TERM AND PREMISES

- A. The Farleys, as lessors and optionors, entered into a Mining Lease and Option to Purchase Agreement, dated effective as of November 4, 1991, with Barrick Gold Exploration Inc., as lessee and optionee (the "Lease"), pertaining to certain real property located in Eureka County, Nevada, which property is more particularly described in Exhibit A attached hereto (the "Property"). The initial term of the Lease was for five years.
- B. Barrick Gold Exploration Inc. assigned the Lease to Barrick by an Assignment dated June 30, 1994.
- C. Barrick and Gold Ventures entered into the High Desert and Barrick Gold Venture Agreement, effective May 1, 1994 (the "Venture Agreement"), pursuant to which Gold Ventures acquired an undivided interest in the Lease. Barrick and Gold Ventures ("Barrick/Gold Ventures") now hold their interest in the Lease as tenants in common subject to the Venture Agreement.
- D. The parties have entered into a First Amendment of Mining Lease and Option to Purchase Agreement, dated September, 1996 (the "Lease Amendment"). The Lease Amendment extends the term of the Lease for another five years, until November 4, 2001.
