IN WITNESS WHEREOF, the said Grantors have executed this Deed as of the day and year first hereinabove written.

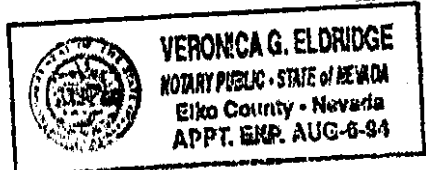
