

**CERTIFICATE OF LOCATION**

NOTICE IS HEREBY GIVEN that BHP Minerals International Exploration Inc., 5330 South 900 East, Salt Lake City 84117, a Delaware corporation, hereby claims under and pursuant to the laws of the state of Nevada and of the laws of the United States of America the following described LODE MINING CLAIM:

The name of the claim is the KP 56.

This claim was located on Sept. 17, 1996, by posting a Location Notice at the discovery monument found at, on, or near the east end of the claim.

The length of the claim is 10 feet in a east direction and 1490 feet in the opposite direction from the monument where the Location Notice is posted, and the width is 300 feet on each side of the center of the vein or lode, comprising in all 1500 feet in length and 600 feet in width, and generally following a east-west course.

The exterior boundaries are distinctly marked by four substantial monuments of stone or wooden posts at least 1-1/2 inches in diameter by four feet in length, set one foot in the ground, one at each corner. The boundaries can be readily traced by beginning at corner No. 1, the Northeast corner:

- thence 600 feet south to the SE,
- thence 1500 feet west to the SW,
- thence 600 feet north to the NW,
- thence 1500 feet east to the NE,

the point of beginning.

The northeast corner of this claim, corner No. 1, is found about 5275 feet north and 2510 feet west from the SW corner of section 13 Township 21 South, Range 50 East M.D.B.M.

Said claim is located in the:

- NE 1/4 of section 14, Township 21 N, Range 50 E, M.D.B.M.
  - SE 1/4 of section \_\_\_\_\_, Township 21 N, Range 50 E, M.D.B.M.
  - NW 1/4 of section 14, Township 21 N, Range 50 E, M.D.B.M.
  - SW 1/4 of section \_\_\_\_\_, Township 21 N, Range 50 E, M.D.B.M.
- Eureka County, State of Nevada.

The boundaries of said claim were defined by law within sixty days from the date of posting of the Notice of Location. The location work, consisted of the making and filing of maps and the payment of fees prescribed by NSR 517.040, was completed by the date of recordation of this certificate.
