KNOW ALL MEN BY THESE PRESENTS, that I, GRACE SALLABERRY, also known as GRACIEUSE SALLABERRY or GRATIENE SALLABERRY, of Reno, Nevada, have executed a REVOCABLE INTERVIVOS TRUST entitled THE GRACE SALLABERRY REVOCABLE TRUST on the 22nd day of November, 1996; that GRACE SALLABERRY, MARY JEAN LABARRY and GRACIAN SALLABERRY are Co-Trustees thereof. Should GRACE SALLABERRY cease to act as Trustee, MARY JEAN LABARRY and GRACIAN SALLABERRY shall continue to act as Co-Trustees with ALBERTINE PRINA acting as Successor Trustee to GRACE SALLABERRY. Thereafter, any subsequent vacancy in the position of Trustee shall be filled by VERONICA STINNETT. All of the Trustees are by the term of said Trust given the full power of investment of the Trust Estate, without the necessity of supervision of any court, authorization to keep any and all securities or other property constituting a part or all of the Trust property in the name or names of Trustees, without disclosing their fiduciary capacity, or to hold securities in the name of a nominee, together with all of the powers provided to Trustees by Nevada Revised Statutes, Section 163.260 through 163.410. Power vested in three (3) or more trustees may be exercised by a majority of such trustees as provided in NRS 163.110, but I may act alone as trustee in exercising any power.

Persons or corporations dealing with the Trustees are expressly exonerated from any duty to inquire into the authority or power of the Trustees or to see the application of
