

**ASSIGNMENTS OF PARTICIPATING INTERESTS AND LEASEHOLD INTERESTS  
ASSUMPTION OF OBLIGATIONS**

For and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Barrick Goldstrike Mines Inc., a Colorado corporation, whose address is Post Office Box 29, Elko, Nevada 89803 ("BGMI") does hereby assign and transfer to Barrick Gold Exploration Inc., an Ohio corporation with offices at 293 Spruce Road, Elko, Nevada 89801 ("BGE"), all of its rights, titles and interests in and to the following:

(i) as Tenants in Common, and not as joint tenants, all of its rights, titles and interests, in and to that certain Mining Lease and Option to Purchase Agreement (the "Agreement"), dated effective as of November 4, 1991 by and between Robert L. Farley and Georgia Lynn Farley, husband and wife, of 4916 Allamar Drive, Boise, Idaho 83704; Carl A Farley and Donna L. Farley, husband and wife, of Route 2, Box 702, Ontario, Oregon 97914 and Barrick Gold Exploration Inc., an Ohio corporation, as amended and extended by that certain First Amendment to Mining Lease and Option to Purchase Agreement dated effective as of September 1, 1996 between the Farleys and Barrick Goldstrike Mines Inc. a Colorado corporation and the successor to Barrick Gold Exploration Inc., and whose address is P.O. Box 29, Elko, Nevada 89803 and Gold Ventures, Inc., a Nevada corporation whose address is P.O. Box 2008, Elko, Nevada 89803 covering the unpatented lode mining claims described in Schedule One of such Agreement.

(ii) all of its Participating Interest in and to that certain High Desert and Barrick Gold Venture Agreement between BGMI and Gold Ventures, Inc., Effective May 1, 1994, as amended (the "Venture Agreement"), including all of its interests in the Venture Agreement and the "Assets", as defined therein, including without limitation the right, upon certain conditions, to obtain a majority of the Participating Interests under the Venture Agreement.

By a Mining Claim Quitclaim Deed and Assignment dated December 18, 1996, BGMI has conveyed an undivided 69% of BGMI's rights, titles and interests in the Venture Agreement and the properties subject to the Venture Agreement, to Gold Ventures, Inc., a Nevada corporation. The remaining undivided 31% of BGMI's rights, titles and interests in such Venture Agreement and such properties, are being transferred by this instrument and that Mining Claim Quitclaim Deed granted to BGE of even date herewith. As a consequence, BGMI has transferred all of its interests in the Venture Agreement, the Assets (as defined therein), and its Participating Interest therein. Provided, however, that the foregoing Assignment does not release BGMI from its obligations under the Venture Agreement prior to the date hereof. BGE hereby agrees to assume and perform those obligations and to hold BGMI harmless from any and all liabilities and claims arising from those obligations and further agrees, from and after the date hereof, to be bound by the Venture Agreement as a Participant and to be same extent as BGMI was bound as a Participant.


