CERTIFICATE OF LOCATION LODE MINING CLAIM

Notice is hereby given that BHP Minerals International Inc., 5330 South 900 East, Suite 200, Salt Lake City, Utah 84117 hereby locates and claims the following described mineral bearing ground as a lode claim:

From this point of discovery (monument of location) one thousand four hundred ninety feet (1490 feet) in a West direction, ten feet (10 feet) in a East direction, and three hundred feet (300 feet) on each side of the center line of the claim.
