NOTICE AND CLAIM OF LIEN

NOTICE IS HEREBY GIVEN, that SUMMIT ENGINEERING CORPORATION, a Nevada corporation, hereby claims a mechanic's and materialman's lien upon the property hereinafter particularly described, in Exhibit A attached hereto and incorporated by reference. 7. That a demand for payment has been made by the lien claimant and that the amount set forth in paragraph 6 above remains due and owing.

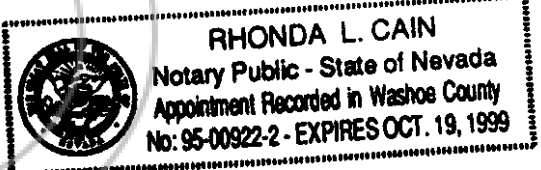
