

GRANT BARGAIN AND SALE DEED

1 THIS INDENTURE made as of the 20th day of February, 1997, by and between
2 THE BOARD OF COUNTY COMMISSIONERS, acting as a Town Board for the
3 unincorporated town of Eureka, Nevada, party of the first part; and STEVEN E. and VADA L.
4 HUBBARD, 396 Russell Way, Gardnerville, NV 89410, party of the second part, a married
couple;

7 That First Party, the Grantor, for and in consideration of the sum of TEN
8 DOLLARS (\$10.00), to it in hand paid by Second Party, and other good and valuable
9 consideration, the receipt of same being acknowledged hereby, does by these presents grant,
10 bargain, sell, and convey unto the Grantee, said Second Party, their heirs, successors, and
11 assigns forever, all that certain lot, piece or parcel of land situate, lying and being in the Town
12 of Eureka, County of Eureka, State of Nevada, which property was formerly a portion of Nob
Hill Avenue before that portion was abandoned, and more particularly described as follows,
to-wit:

13 All that certain real property situate in a portion of the Southeast 1/4 of Section 14,
14 Township 19 North, Range 53 East, M.D.B. & M., further described as the East 1/2 of
15 Nob Hill Avenue adjacent to Lots 1 & 2, Block 76, as shown on the plat of Eureka
16 Townsite, on file in the office of the U.S. Department of the Interior, recorded in 1937,
more particularly described as follows:

17 BEGINNING at the Northwest corner of Lot 2, Block 76;
18 THENCE S 09°09'00" E, a distance of 51.35 feet;
19 THENCE S 80°51'00" W, a distance of 22.60 feet;
20 THENCE N 08°57'31" W, a distance of 51.35 feet;
21 THENCE N 80°51'00" E, a distance of 22.43 feet to the TRUE POINT OF
BEGINNING.


