13 ROBERT E. WILLIAMS, and

16 IT IS HEREBY STIPULATED by the parties hereto that
17 the Plaintiff have judgement against the Defendant, ROBERT
18 E. WILLIAMS in the principal amount of \$46,006.30, along
19 with \$153.50 in costs and attorney's fees in the amount of
20 \$500.00, with interest on \$30,136.81 at the rate of 7.5% per
21 annum from January 11, 1996 until paid in full, interest on
22 \$13,826.67 at 14.9% per annum from January 11, 1996 until
23 paid and interest on \$2,042.82 at 17% per annum from January
24 11, 1996 until paid in full.

25 IT IS FURTHER AGREED by the parties that the
26 Defendant shall make the following payments:

27 Defendant is to make a payment to the Plaintiff in
28 the amount of \$2,695.29 by March 25, 1996 and then is to

1 commence making monthly payments of \$1,009.57 by April 25,
2 1996 and continue with said payment until and the sums
3 stated above are paid in full. Thereafter the Plaintiff
4 shall file a satisfaction of judgment with this Court.

5 The payments shall be made directly to GREAT BASIN
6 FEDERAL CREDIT UNION c/o Michael Lehnars, Esq., 429 Marsh
7 Avenue Reno, Nevada 89509. Each payment shall fall due on
8 25th day of each month.

9 The Plaintiff hereby agrees to suspend execution
10 with the respect to this judgment so long as the Defendant
11 comply with the provisions in this document. In the event
12 that said Defendants default with respect to any of the
13 terms expressed above, the Plaintiff shall give the
14 Defendant notice of the default in writing by both certified
15 and regular mail addressed to Defendant at P. O. Box 291,
16 Eureka, NV 89316, and, if the Defendant fail to cure said
17 default within ten (10) days from the date of such notice
18 was sent out, the Plaintiff may commence to execute.

19 IT IS FURTHER AGREED that the Plaintiff has in no
20 way given up its security interest as to the Defendant's
21 1989 motor home and in the event of a default of this
22 agreement, Plaintiff can immediately repossess this
23 collateral.

24 IT IS FURTHER AGREED that in the event that
25 Plaintiff sends Defendant a notice of default pursuant to
26 the terms above, and the Defendant cure the specified
27 default, Plaintiff shall be entitled to add the sum of
28

1 \$35.00 to the then existing balance. In the event that the
2 Defendant fails to timely cure said default, Plaintiff shall
3 be entitled to all reasonable costs of collection which are
4 incurred with respect to recovering the remaining balance
5 due at the time of default. Any such costs shall be
6 itemized in a supplemental costs memorandum and filed with
7 the Court.

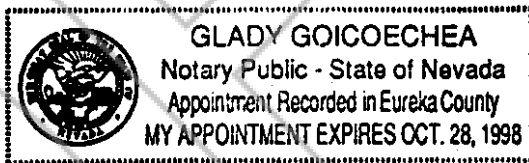
