W I T N E S S E T H:

That the said party of the first part, for and in consideration of the sum of Ten Dollars, lawful money of the United States of America, to her in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do by these presents, grant, bargain, sell, convey, and confirm unto the said party of the second part and to her heirs and assigns forever, all that certain lot and parcel of land, situate in the said County of Eureka, State of Nevada, and bounded and described as follows, to-wit: the NW $\frac{1}{4}$  of <sup>SW</sup> NW $\frac{1}{4}$  of Section 5; the N $\frac{1}{2}$  of the SE $\frac{1}{4}$  of Section 6, and Lot 1 of Section 6, all in Township 19, N. R. 54 E. M. D. B. & M. together with all water, water rights, dams, ditches and reservoirs used or connected with the irrigation of the above described land, or otherwise.
