SPECIAL AND LIMITED POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, the Cortez Joint Venture, also known as the Cortez Gold Mines, a joint venture (both referred to hereinafter as "The Joint Venture") wishes to appoint two new Attorneys-in-Fact for the same purposes as set forth in the Special and Limited Power of Attorney previously granted to Mr. Jay K. Taylor, dated June 1, 1995 and filed and recorded on (i) June 7, 1995 in Book 895, at Page 104, as File No. 368713, Elko County Recorder's Office; (ii) June 12, 1995 in Book 417, at Page 745, as File No. 193675, Lander County Recorder's Office; and (iii) June 13, 1995 in Book 283, at Page 425, as File No. 158130, Eureka County Recorder's Office, which is now revoked and superseded;

Jeannes, Vice President and General Counsel, both of Placer Dome U.S. Inc., the Manager of The Joint Venture, to be its true and lawful Attorneys-In-Fact, either one of them to act in its place and stead for the following specific purposes only:

To make, sign, seal, execute, acknowledge, deliver or receive, on behalf of The Joint Venture and in its name, such agreements, documents, deeds, deeds of trust, releases and reconveyances, subordination agreements and any other instruments in writing as may be necessary in administering the housing assistance program for employees of Cortez Gold Mines or The Joint Venture.

That The Joint Venture hereby agrees to ratify, allow and confirm whatsoever its attorneys shall lawfully do, or cause to be done, for and in its name, by virtue hereof.
