

CERTIFICATE OF LOCATION FOR LODE MINING CLAIM

Locator claims 1,500 linear feet along the course of the mineral bearing ledge, lode or vein,
extending 1,200 feet from the location monument in a Northwesterly direction and 300
feet in a Southeasterly direction, together with 300 feet on each side of the center of the ledge
for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by 2"x2"x4' long wooden post monuments
firmly set in the ground and bearing applicable monument designation. The description of such claim is:
