CERTIFICATE OF LOCATION

NOTICE IS HEREBY GIVEN that BARRICK GOLD EXPLORATION INC., 293 Spruce Raod, Elko Nevada 89801-4491, hereby claims under and pursuant to the laws of the state of Nevada and of the laws of the United States of America the following described LOPE MINING CLAIM:

The name of the claim is the BKV # 90
This claim was located on April 30, 1997, by posting a Location Notice at the discovery monument found at, on, or near the west end of the claim.

The length of the claim is 20 feet in a west direction and 1480 feet in the opposite direction from the monument where the Location Notice is posted, and the width is 300 feet on each side of the center of the vein or lode, comprising in all 1500 feet in length and 600 feet in width, and generally following a East-West course.

The exterior boundaries are distinctly marked by four substantial monuments of stone or wooden posts at least 1-1/2 inches in diameter by four feet in length, set one foot in the ground, one at each corner. The boundaries can be readily traced by beginning at corner No. 1, the Northeast corner:

thence 600 feet	South	to the Southeast
