

NOTICE OF CLAIM OF LIEN

NOTICE IS HEREBY GIVEN THAT HACKWORTH DRILLING, INC., a Nevada corporation, of P.O. Box 850, Elko, Nevada, 89803, claims a Mechanic's and Materialmen's Lien upon the property hereinafter more particularly described, which property is located in Elko County, Nevada, on which claim is made pursuant to the laws of the State of Nevada, particularly Chapter 108 of the Nevada Revised Statutes, as amended, for the value of work, labor, materials and/or services furnished by the lien claimant for the improvement of real property hereinafter more particularly described and located in the County of Elko, State of Nevada.

That the real property hereinafter described has been or is in the process of improvement.

Claimant further claims:

1. That the name and address of the owner or reputed owner of the premises sought to be charged is RONALD E. JOLLY, Unit 3 HC 66 3-7, Beowawe, Nevada, 89821.

Said sum is now due and owing to the lien claimant in total amount plus interest of eighteen percent (18%) per annum from June 30, 1997, until paid and costs and expenses incurred to date of \$300.00 for a total due and owing of \$11,032.17.

5. That the first labor and materials furnished by lien claimant to incorporate into the project was on or about May 14, 1997, and that the last labor and materials furnished by lien claimant and incorporated into the project was on or about May 22, 1997; that there are no other credits or offsets to be deducted and that the total amount due and owing to the lien claimant is the sum of \$11,032.17 plus interest.

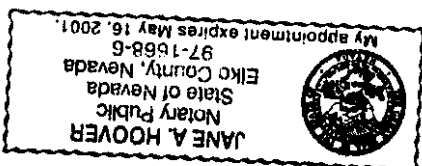
