

CERTIFICATE OF LOCATION

NOTICE IS HEREBY GIVEN that ROMARCO NEVADA, INC., a Nevada Corporation, 5450 Riggins Court Suite 2, Reno Nevada 89502, hereby claims under and pursuant to the laws of the state of Nevada and of the laws of the United States of America the following described LOPE MINING CLAIM:

The name of the claim is the UM 46
This claim was located on May 27, 1997, by posting a Location Notice at the location monument found at, on, or near the east end of the claim.

The length of the claim is 20 feet in a east direction and 1480 feet in the opposite direction from the monument where the Location Notice is posted, and the width is 300 feet on each side of the center line of the claim, comprising in all 1500 feet in length and 600 feet in width, and generally following a East - West course.

The exterior boundaries are distinctly marked by four substantial monuments of stone or wooden posts at least 1-1/2 inches in diameter by four feet in length, set one foot in the ground, one at each corner. The boundaries can be readily traced by beginning at corner No. 1, the Northeast corner:

thence	600	feet	South	to the	Southeast corner.
thence	1500	feet	West	to the	Southwest corner.
thence	600	feet	North	to the	Northwest corner.
thence	1500	feet	East	to the	Northeast corner.

The northeast corner of this claim, corner No. 1, is found about 3000 feet South and 3500 feet East from the NW corner of section 32 Township 27 N Range 53 E M.D.B.M.
