CERTIFICATE OF LOCATION

NOTICE IS HEREBY GIVEN that ROMARCO NEVADA, INC., a Nevada Corporation, 5450 Riggins Court Suite 2, Reno Nevada 89502, hereby claims under and pursuant to the laws of the state of Nevada and of the laws of the United States of America the following described LODE MINING CLAIM:

The name of the claim is the UM 83.

This claim was located on May 28, 1997, by posting a Location Notice at the location monument found at, on, or near the north end of the claim.

The length of the claim is 20 feet in a north direction and 1180 feet in the opposite direction from the monument where the Location Notice is posted, and the width is 150 feet on each side of the center line of the claim, comprising in all 1200 feet in length and 300 feet in width, and generally following a north-south course.

The exterior boundaries are distinctly marked by four substantial monuments of stone or wooden posts at least 1-1/2 inches in diameter by four feet in length, set one foot in the ground, one at each corner. The boundaries can be readily traced by beginning at corner No. 1, the Northeast corner:

thence 1200 feet South to the Southeast corner,  
thence 300 feet West to the Southwest corner,  
thence 1200 feet North to the Northwest corner,  
thence 300 feet East to the Northeast corner,

the point of beginning.

The northeast corner of this claim, corner No. 1, is found about 6600 feet South and 800 feet East from the NW corner of section 32 Township 27 N, Range 53 E M.D.B.M.
