CERTIFICATE OF LOCATION OF LODE MINING CLAIM

KNOW ALL MEN BY THESE PRESENTS, That the undersigned hereby certifies that:

has located the PDRH # 158 Lode Mining Claim on the 19 day of July, 1997, whose dimensions are 1500 feet by 600 feet. By this Declaration and such location, the above named locator(s) claim all veins, lodes, ledges, deposits and surface ground within the boundaries of said claim.

Said claim is a lode it being situated in the above mentioned county and state, and it is distinctly marked on the ground so that its boundaries may be readily traced by four 2" X 2" wooden posts four feet long. Each monument is marked with a scribed metal tag, which states the claim name and number, and the location of the monument with respect to the claim.

Beginning at the NE corner (Cor. No. 1), thence 600 feet South to the SE corner (Cor. No. 2), thence 1500 feet West to the SW corner (Cor. No. 3), thence 600 feet North to the NW corner (Cor. No. 4), thence 1500 feet East to the Point of Beginning.

To tie this claim to a Public Survey, the NE Corner (Cor. No. 1) of this claim lies approximately 2350 feet SOUTH and 200 feet WEST from the NE corner of Section 1, Township 27 North, Range 48 East, Mount Diablo Base Line and Meridian, projected.
