 CERTIFICATE OF LOCATION - LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

That American Carbonate Rock Inc., by and through their lawful and authorized agent, Barry K. Bradshaw, gives notice that he/they claims the land described below as a lode mining claim pursuant to the laws of the United States of America and the State of Nevada, and in making such claim and establishing his/their rights, states and certifies as follows:

1. The name of the claim is BRC 6.

The claim is 1500 feet long and 600 feet wide, such that 10 feet is claimed in a Northernly direction and 1490 feet in a Southernly direction from the discovery monument, at which the location notice is posted, lengthwise of the claim, together with 300 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode or vein is Northernly and Southernly as nearly as can be determined.
