**AFFIDAVIT OF NOTICE OF INTENT TO HOLD UNPATENTED MINING
CLAIMS AND/OR MILL SITES AND NOTICE OF MAINTENANCE FEE
PAYMENT IN LIEU OF ASSESSMENT WORK**

The undersigned, of lawful age, being first duly sworn, deposes and says:

1. That I am personally acquainted with the 148 unpatented claims known as the RP 1-54, 62-71, 79-88, 96-109, 117-125, 127, 135-156, 161-174, 186-197, 201, 202, described in the attached Exhibit "A".
2. That the mining claims are located in the sections, townships, and ranges M.D.B.&M., Eureka County, State of Nevada, being more particularly described in Exhibit "A" attached hereto and incorporated herein, and that the book and page numbers wherein the original location certificates or latest amendment or relocation certificates for each claim is recorded as they appear.
3. That the \$100.00 per claim maintenance fee required by the Act of August 10, 1993 (Public Law 103-66, 107 Stat. 312) for the assessment year ending September 1, 1997 and September 1, 1998 has been paid to hold the mining claims or mill sites on August 20, 1997 and it is the intent that the claims be held. 5. That such payments constitute the annual work or improvements required by the laws of the United States in order to prevent the forfeiture of claims as required by NRS. 517.230.
6. That the maintenance fees were paid by Romarco Nevada, Inc. as the owners of the claims.

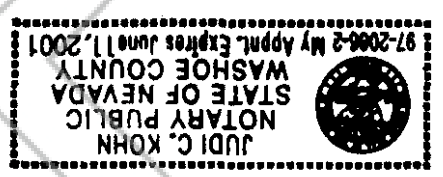
