I am the duly authorized agent of NEWMONT GOLD COMPANY, a Delaware corporation ("Newmont"), and am personally acquainted with the matters described herein.

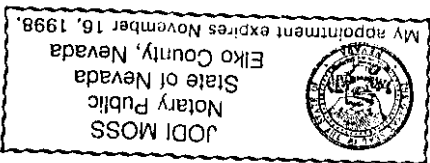
