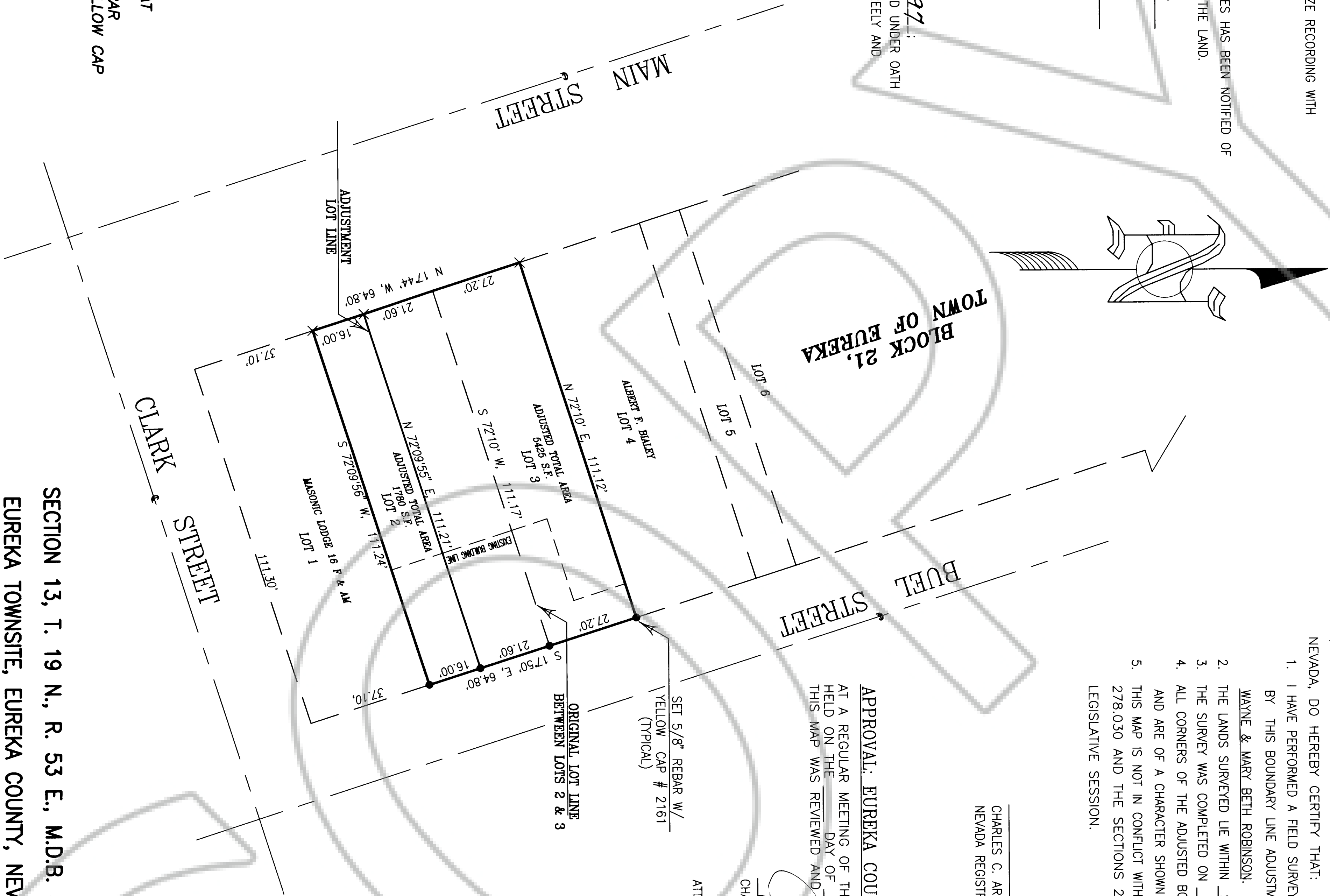

AND TOPPED WITH LUMOS AND ASSOCIATES, PLS YELLOW CAP

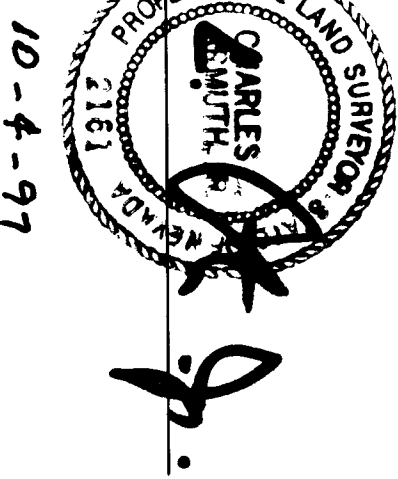


SURVEYOR'S CERTIFICATE

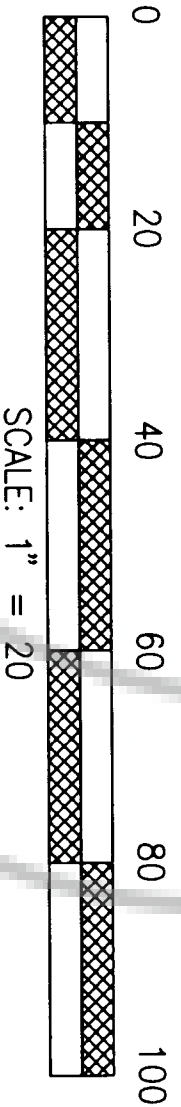
