

AGREEMENT AMENDING THE TERMS SET FORTH
IN NOTE AND TRUST DEED/MORTGAGE

THIS INDENTURE made and entered into the day and year set forth hereinafter by and between
Tyler Wallack and Aimee Wallack, husband and wife, hereinafter referred to as Grantors and Bank of
Eastern Idaho hereinafter referred to as Beneficiary, WITNESSETH:

WHEREAS, the Grantors did on February 1, 1997, make, execute and deliver to the Beneficiary
a certain Note and Trust Deed in the amount of ONE HUNDRED TWENTY-TWO THOUSAND NINE
HUNDRED FIFTY-THREE AND 41/100 (\$122,953.41) covering the premises situated in Eureka
County, State of Nevada, hereinafter referred to and described as follows:

TOGETHER WITH ALL IMPROVEMENTS SITUATE THEREON.

TOGETHER WITH THE TENEMENTS, HEREDITAMENTS AND APPURTENANCES
THEREUNTO BELONGING OR IN ANYWISE APPERTAINING, AND THE REVERSION
AND REVERSIONS, REMAINDER AND REMAINDERS, RENTS, ISSUES AND PROFITS
THEREOF.

AND WHEREAS the said Trust Deed/Mortgage was recorded February 3, 1997 as Instrument
No. 166087 in the records of Eureka County, State of Nevada and provided the date of maturity to be
June 5, 1997, and whereas the said Trust Deed/Mortgage was amended on June 20, 1997, recorded on
June 30, 1997, as Instrument No. 167161 in the records of Eureka County, State of Nevada and provided
the date of maturity to be August 5, 1997.

NOW, THEREFORE, IT IS COVENANTED AND AGREED AS FOLLOWS:

Maturity date amended to November 5, 1999. Amount of Deed of Trust amended to ONE HUNDRED
TWENTY-ONE THOUSAND, SEVEN AND 80/100 Dollars (\$121,007.80).

That in all other respects the conditions, provisions and terms contained in both the Note and Trust Deed
be, and the same are, ratified and confirmed.

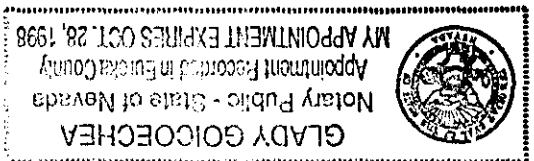

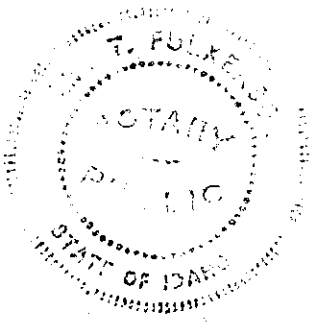
