11 fee in the sum of \$750.00, together with court costs incurred to

12 date of \$166.20 and court costs to be incurred by Plaintiff in

13 connection herewith.

14 3. That Plaintiff is entitled to interest on the sum of

15 \$2,374.82 at the rate of two percent (2.0%) per month from April

16 30, 1996, until paid.

17 NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND

18 DECREED that the Plaintiff have judgment against the Defendant,

19 EDWIN A. FORTNER, as follows:

20 1. Principal sum of \$2,374.82.
