CERTIFICATE OF LOCATION OF LODE MINING CLAIM STATE OF NEVADA, COUNTY OF EUREKA

has located the P 107 Lode Mining Claim on the 4 day of SEPTEMBER, 1997 whose dimensions are approximately 1500 feet by 600 feet. By this Declaration and such location, the above name locator(s) claim all veins, lodes, ledges, deposits and surface ground within the boundaries of said claim.

Said claim is a lode it being situated in the above mentioned county and state, and it is distinctly marked on the ground so that its boundaries may be readily traced by four 2" x 2" wooden post four feet long. Each monument is marked with a scribed metal tag, which states the claim name and number, and the location of the monument with respect to the claim.

Beginning at the NE corner (Cor. No. 1), thence 600 feet S 50° E to the SE Corner (Cor. No. 2), thence 1500 feet S 40° W to the SW Corner (Cor. No. 3), thence 600 feet N 50° W to the NW Corner (Cor. No. 4), thence 1500 feet N 40° E to the Point of Beginning.

The Claim is approximately 1500 feet long and 600 feet wide, such that 20 feet are claimed in a N 40° E direction and 1480 feet in a S 40° W direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the Claim. The general course of the lode or vein is from the North East to the South West direction.
