To tie this claim to the Public Survey, begin at the NE corner of Section 25, Township 20 North, Range 52 East, Mount Diablo Base and Meridian, thence approximately azimuth bearing 5° for 5560 feet to the NE corner of this claim.

The general course of the lode or vein is east and west.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein, extending 25 feet from the location monument in a East direction and 1475 feet in a West direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by wood posts, firmly set 1 foot in the ground and bearing applicable monument designation. The description of such claim is:

Beginning at the Northeast Corner: 600 feet to the SE corner, a 2" x 2" x 4' in length wood post, thence, South 600 feet to the SW corner, a 2" x 2" x 4' in length wood post, thence, West 1500 feet to the NW corner, a 2" x 2" x 4' in length wood post, thence, North 600 feet to the NE corner, a 2" x 2" x 4' in length wood post, thence, East 1500 feet to the NE corner, a 2" x 2" x 4' in length wood post, the point and place of beginning.

The monumentation and marking of the exterior boundaries of this claim was completed by the 6th day of December, 1997.
