The general course of the lode or vein is east and west.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein, extending 1475 feet from the location monument in a East direction and 25 feet in a West direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by wood posts, firmly set 1 foot in the ground and bearing applicable monument designation. The description of such claim is:
