Locator claims 1,370 linear feet along the course of the mineral bearing ledge, lode or vein, extending 1,345 feet from the location monument in a Southwesterly direction and 25 feet in a Northeasterly direction, together with 262.5 feet on each side of the center of the ledge for the entire length of the claim.
