Locator claims 1,409.8 linear feet along the course of the mineral bearing ledge, lode or vein, extending 1,379.8 feet from the location monument in a Northeasterly direction and 30 feet in a Southwesterly direction, together with 251 feet on each side of the center of the ledge for the entire length of the claim.
