CERTIFICATE OF LOCATION OF LODGE MINING CLAIM

whose dimensions are 1500 feet by 600 feet. By this Declaration and such location, the above
named locator(s) claim all veins, lodes, ledges, deposits and surface ground within the boundaries
of said claim.

Said claim is a lode it being situated in the above mentioned county and state, and it is
distinctly marked on the ground so that its boundaries may be readily traced by four 2" X 2"
wooden posts four feet long. Each monument is marked with a scribed metal tag, which states the
claim name and number, and the location of the monument with respect to the claim.

Beginning at the NE corner (Cor. No. 1), thence 600 feet South to the SE Corner (Cor. No.
2), thence 1500 feet West to the SW Corner (Cor. No. 3), thence 600 feet North to the NW
corner (Cor. No. 4), thence 1500 feet East to the Point of Beginning.

approximately 7125 feet south and 450 feet east from the NW Corner of Section 3,
Township 26 North, Range 52 East, Mount Diablo Base Line and Meridian.
