4 IT IS HEREBY ORDERED that the default of the Defendant,
5 EUROPEAN AMERICAN RESOURCES INCORPORATED (EPAR), be and the same is
6 hereby entered by the Court.

7 IT IS FURTHER APPEARING TO THE COURT:

8 1. That Plaintiff is entitled to Default Judgment
9 against the Defendant, EUROPEAN AMERICAN RESOURCES INCORPORATED
10 (EPAR), and that Defendant is indebted to the Plaintiff in the sum
11 of \$89,553.05 for drilling services, for which Defendant has failed
12 and refused to pay.

13 2. That Plaintiff is entitled to a reasonable attorney
14 fee in the sum of \$10,000.00, together with court costs incurred to
15 date of \$329.00 and court costs to be incurred by Plaintiff in
16 connection herewith.

17 3. That Plaintiff is entitled to interest on the sum of
18 \$89,553.05 at the rate of one and one-half percent (1.5%) per month
19 (eighteen (18%) percent per annum) from November 26, 1997, until
20 paid.

21 NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND
22 DECREED that the Plaintiff have judgment against the Defendant,
23 EUROPEAN AMERICAN RESOURCES INCORPORATED (EPAR), as follows:

24 1. Principal sum of \$89,553.05.
25 2. For interest on the principal sum of \$89,553.05 at
26 the statutory rate of one and one-half percent (1.5%) per month
