SUBSTITUTION OF TRUSTEE AND RECONVEYANCE

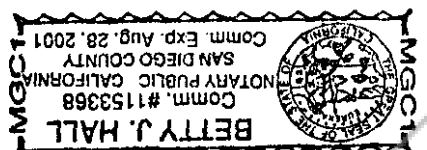
