CERTIFICATE OF LOCATION

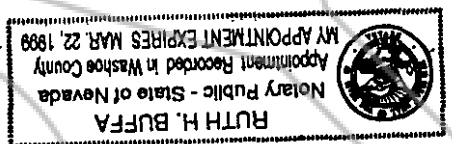
