Corner No. 4, the SW Corner, is a 1½"x1½"x4' wooden post marked "SW GAP 103".

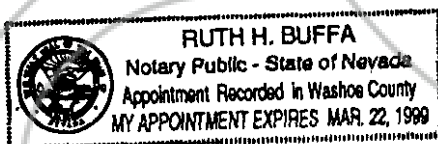
