

CERTIFICATE OF LOCATION

Corner No. 4, the SW Corner, is a 1 1/2"x1 1/2"x4' wooden post marked "SW GAP 104"

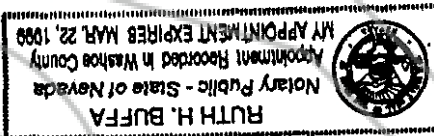
