AMENDED CERTIFICATE OF LOCATION  
State of Nevada Lode Claim

The undersigned GENERAL MINERAL DEVELOPMENT COMPANY, a Nevada limited partnership, whose address is P.O. Box 11856, Reno, Nevada 89510, certifies that it has amended the 12037 lode mining claim, more particularly described below. The original location was the 3rd day of May, 1990.
