AMENDED CERTIFICATE OF LOCATION  
State of Nevada Lode Claim

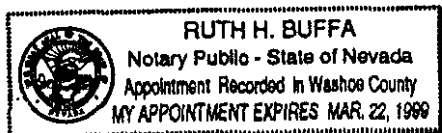
