## AMENDED CERTIFICATE OF LOCATION State of Nevada Lode Claim

The undersigned GENERAL MINERAL DEVELOPMENT COMPANY, a Nevada limited partnership, whose address is P.O. Box 11856, Reno, Nevada 89510, certifies that it has amended the ROB 25 lode mining claim, more particularly described below. The original location was the 4th day of May, 1990. The original certificate of location was recorded in the Official Records of Eureka County, Nevada in Book 211 at page 116, and filed with the Bureau of Land Management under Serial Number NMC 599932. The date of amendment is the 6th day of July, 1998.

The number of linear feet claimed in length along the course of the vein, each way from the point of discovery, is 1480 feet in a west direction and 20 feet in a east direction. The width claimed on each side of the center of the vein is 300 feet. The general course of the lode or vein, as near as may be determined, is east-west.
