AMENDED CERTIFICATE OF LOCATION  
State of Nevada Lode Claim

The undersigned GENERAL MINERAL DEVELOPMENT COMPANY, a Nevada limited partnership, whose address is P.O. Box 11856, Reno, Nevada 89510, certifies that it has amended the ROB 29 lode mining claim, more particularly described below. The original location was the 4th day of May, 1990. The date of amendment is the 6th day of July, 1998.
