

NOTICE OF LIEN CLAIM

NOTICE IS HEREBY GIVEN:

1. That **William H. Ruby**, doing business as **A.T.F. CONCRETE**, a branch of **CONSTRUCTION SERVICES, LTD.**, a Nevada Limited Liability Company, hereby claims a mechanic's lien pursuant to the provisions of NRS 108.22, et seq., laws of the State of Nevada, on the real property and improvements situate in the County of Eureka, Parcel #5, commonly known as Emigrant Pass, Nevada.

2. The names of the owner or reputed owner of the above described property is **JAMES KLINE**, whose address is 1715 Pine, Carlin, Nevada, 89822.

3. This lien is claimed for material supplied and for labor performed on the property and improvements described in paragraph 1 above. Said labor and materials consisted of the placement of a ply rock texture on the exterior of the foundation of the modular home located on the property described in Paragraph 1.

4. That said labor and materials were supplied at the order of **Sid Chambless, Sr.** On or about July 14, 1998, Mr. Chambless contracted with **A.T.F. CONCRETE** to set, pour, finish, and strip the foundation for the modular home at Parcel #5, Emigrant Pass, Nevada. Mr. **CHAMBLESS** has not paid any monies to date.

5. Pursuant to NRS 108.226(1)(a), ninety (90) days have not elapsed since the completion of the work of improvements on the property described above upon which the lien claimant's material was used and labor was performed.

6. That the claimant herein is entitled to reasonable attorney fees, statutory interest on the amount of this lien claim, and costs incurred in perfecting this lien claim.

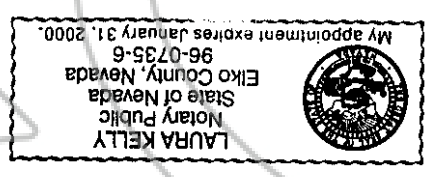
