Corporation, was named as Lessee, and Elmer F. Schroeder and Elna

Ruth Schroeder, his wife, were named as Lessors.

4 3. Said Lease granted to Lessee an option to purchase for

5 the total sum of \$75,000.00, with all rental payments made during

6 the term of said Lease to be applied against the purchase price.

7 The Lease further provided that the final payment on the purchase

8 price would be made upon the delivery and recording of a Deed

9 transferring said property and mining claims to the Lessee.

10 4. The remaining balance of the purchase price is now

11 \$15,000.00 and Lessee has offered payment of said sum and has

12 requested the execution and delivery of a Deed to said property and

13 mining claims.

14 5. Pursuant to the provisions of NRS, Section 149.110,

15 Petitioner is bound to make a conveyance of said mining claims to

16 Lessee, Cortez Mines, a joint venture, acting through its managing

17 co-venturer, Placer Amex, Inc., a California Corporation, upon

18 payment in full of the balance of the purchase price in the sum of

19 \$15,000.00.
