MEMORANDUM OF MINERAL LEASE AGREEMENT

NOTICE IS HEREBY GIVEN that Dixie Ventures LLC, a Nevada Limited Liability Company, whose address is 100 Lemming Drive, Reno Nevada 89523 (therein and hereinafter referred to as "Lessor"), and Kennecott Exploration Company a Delaware corporation whose mailing address is 961 Matley Lane, Suite 120, Reno, Nevada 89502, with an office at 224 North 2200 West, Salt Lake City, Utah 84116, (therein and hereinafter referred to as "KEC"), have entered into a Mineral Lease Agreement ("Agreement") effective as of October 1, 1998 with respect to the unpatented lode mining claims described in Exhibit "A" attached hereto and by this reference made a part hereof, and which unpatented mining claims are therein and hereinafter referred to as the "Premises".
