14 their successors and assigns, all right, title and interest in and
15 to the Consent Judgment which Plaintiff has or may have therein,
16 and hereby declares the Consent Judgment which Plaintiff has or may
17 have therein, fully paid and satisfied and the Consent Judgment
18 lien fully released and discharged.
