The Board of Directors of Silver Eagle Resources Ltd. has passed a resolution dated January 25, 1999, to return the High Dollar Property to you immediately.

Formal acknowledgement of terminaion of the August 15, 1996, Joint Venture Agreement between Silver Eagle Natural Resources, Inc., Seven Gold Corporation, and Jon P. Broderick was received from Altaur Gold Explorations Inc. in a letter dated January 25, 1999. Altaur Gold advised us that they were no longer in a position to make the required royalty payments nor continue with the project. Payments were made by Altaur Gold up to August 31, 1998.

The decision to return the property to you has been necessitated by the default on High Dollar by Altaur Gold Explorations Inc., and also, by the current financial status of Silver Eagle. By giving notification to you prior to March 1st of the calendar year, Silver Eagle Resources Ltd. and Silver Eagle Natural Resources, Inc. are not liable for assessment work, filing or holding fees payable to local, county, state or federal agencies on the unpatented claims of this property.

We acknowledge receipt of your letter of December 1<sup>st</sup>, 1998 advising of the default of our wholly-owned subsidiary, Seven Gold Corporation, in making advance royalty funds pursuant to the joint venture agreement made as of August 15<sup>th</sup>, 1996 between Silver Eagle Natural Resources Inc. and Seven Gold Corporation and Jon P. Broderick.

As you are aware, we have been struggling for some time with the project in attempting to obtain adequate financing for our Company and Seven Gold Corporation. Unfortunately, we have not been successful and, in fact, at this time the corporate charter of Seven Gold has been dissolved by the State of Nevada for failure to make proper filings. It is obvious, therefore, as previously advised, we are not in a position to make the required royalty payments, nor are we able to continue with this project. According to our records, we have made all payments up to August 31st, 1998 and as a result of this termination and our financial position we are no longer in a position to make payments.
