ORDER AUTHORIZING  
TRANSFER OF ASSETS OF  
ESTATE OF LOUIS PHILIP  
GIBELLINI, JR., WITHOUT  
ISSUANCE OF LETTERS OF  
PROBATE

This matter came before the Court upon the Petition of JANELLE DIETRICH, by and through her attorney of record, CHARLES E. WELLER, ESQ. Pursuant to NRS 146.070, and the Court being fully advised in the premises, finds as follows:

1. That LOUIS PHILIP GIBELLINI, JR., Decedent herein, died on the 3rd day of July, 1996, in the City of Fremont, County of Alameda, State of California. At the time of his death, decedent owned certain property located in the County of Eureka, State of Nevada.

2. That Decedent left a Will executed on June 6, 1984, the original of which was filed by the Eureka County Clerk on July 15, 1996, and a copy of which was attached to the Petition to Set Aside Estate Without Administration Pursuant to NRS 146.070(2), filed with the Court on January 14, 1999.

3. That Petitioner is the daughter of Decedent and

1 the sole heir of Decedent's estate.

2 4. That a specific description of all of the  
3 decedent's property, located in Eureka County, State of Nevada,  
4 consisted of

5 10 unpatented mining claims known as the  
6 Rift 1-4, Manganese 3, and Black Iron 1, 3-  
7 6, BLM Serial Nos. NMC 82917, 82918, 82919,  
8 82920, 82912, 82900, 82902, 82903 AND 82904,  
located in Section 1-23-34-3526, Township 15  
& 16 North, Range 52 East, Meridian MDBM,  
Eureka County, Nevada.

9 5. That the estimated value of Decedent's property is  
10 less than \$1,000.00. That no liens or encumbrances of record  
11 existed at the time of Decedent's death.

12 6. Petitioner asks the Court to set aside to JANELLE  
13 DIETRICH all property of Decedent's estate.

14 IT IS THEREFORE ORDERED, ADJUDGED AND DECREED:

15 1. That all of Decedent's property in Eureka County,  
16 Nevada, is hereby set aside to Petitioner, JANELLE DIETRICH,  
17 pursuant to Decedent's Will and NRS 146.070(2). Said property is  
18 more particularly described as follows:
