To tie this claim to the public survey, begin at the south-west corner of Section 30, T36N, R50E, and travel North 89° 25' 21" East, 2899.78 feet to the location monument of the claim.

This claim is 600.44 feet long along the center line and 50 feet wide, such that 100 feet is claimed in an easterly direction and 500.44 feet is claimed in a westerly direction from the location monument, together with 25 feet on each side of the location monument and center line of the claim. The general course of the claim and lode is easterly and westerly. This claim is bounded on the north by Goldstrike No. 5, as amended, NMC 57158, on the east by Goldstrike 39F, NMC 641523 and GS Fraction 39, NMC 325247, and on the west by Goldstrike 38F, as amended, NMC 641522 and GS Fraction 38, as amended, NMC 325246 all located in Section 30, T36N, R50E, M.D.B.&M.

The boundaries of this claim are monumented with wooden posts at least 1½ inches by 1½ inches by 4 feet long. Each monument is marked with a scribed metal tag which states the claim name and number.

The corner monuments will be erected within 60 days of the posting of the notice of location. To locate the monuments, begin at the location monument, thence easterly 100 feet more or less, to the center of the east end line, thence northerly 25 feet more or less, to the Point of Beginning, the northeast corner (No.1) of the claim thence:

50.00 feet southerly to the southeast corner (No.2), thence
600.61 feet westerly to the southwest corner (No.3), thence
50.00 feet northerly to the northwest corner (No.4), thence
600.28 feet easterly to the Point of Beginning, the northeast corner
(No.1) of the claim.
