# **GRANT OF EASEMENT**

This GRANT OF EASEMENT is made this <u>28</u> day of May, 1999, by and between Newmont Gold Company ("Newmont") and Elko Land and Livestock Company ("ELLCO"), (collectively, "Grantors"), and Barrick Goldstrike Mines Inc. ("Grantee").

In consideration of \$10.00 and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the following grants, agreements, and covenants are made:

- 1. Grant of Easement. Grantors hereby grant to Grantee, its permitted successors and assigns, a nonexclusive easement (the "Easement") in, over, under and across that portion of the lands described in Exhibit A attached hereto and incorporated herein by reference, in which Grantors or any of them hold an interest (the "Easement Parcels"), for the sole purpose of construction, operation, modification, maintenance and rebuilding of the "Discharge System" described in that certain Settlement Agreement made to be effective as of October 16, 1996, among Newmont, ELLCO, Grantee and Barrick Gold Corporation (the "Settlement Agreement"), the terms of which agreement are incorporated herein by reference. Grantors retain the right to use of the Easement Parcels as provided in Section 4(b) of the Settlement Agreement.
- 2. <u>Grant of Temporary Construction Rights</u>. Grantors also hereby grant to Grantee the right to enter upon and use, on a temporary basis, additional property owned or controlled by Grantors and adjacent to the Easement Parcels as is reasonably necessary for the construction, maintenance, modification or rebuilding of the Discharge System. Grantee will cooperate with Grantors in exercising such rights so as not to interfere unreasonably with Grantors' ranching operations.
- 3. Other Rights. Grantors also hereby grant to Grantee the right to use, maintain and improve roads located across lands owned or controlled by Grantors to cross and traverse property adjacent to the Easement Parcels for the purposes of exercising the rights granted hereunder. As provided in the Settlement Agreement, Grantee's right to use the Easement Parcels shall include the right to fence or otherwise enclose certain of its surface facilities located on the Easement Parcels.
- 4. <u>Term of Easement</u>. The Easement and the other rights granted herein are granted for a term of 20 years from the Effective Date of the Settlement Agreement subject to Grantee's right, under certain circumstances described in Section 4(b) of the Settlement Agreement, to extend the Easement and other rights granted herein.
- 5. <u>Assignment</u>. Except as provided in Section 4(d) of the Settlement Agreement, Grantee shall not assign the Easement or the other rights granted herein without the prior written

consent of Grantors, unless such assignment is made to an affiliate of the Grantee, or in connection with a merger or the sale of substantially all of the assets of Grantee. Any assignment of this Easement or the other rights granted herein shall be made subject to the terms and conditions of the Settlement Agreement.

6. <u>Running of Benefits and Burdens</u>. All provisions of this instrument, including the benefits and burdens, run with the land and are binding upon and inure to the benefit of the respective permitted assigns and successors of Grantors and Grantee.

This Grant of Easement is executed and delivered effective as of the date written above.
