SUMMARY JUDGMENT

15 This matter having come on for a hearing on the 5th day  
16 of March, 1999, G. C. BACKUS, ESQ. appearing for the Estate of  
17 Oliver, Defendant NORBERT WALTER appearing in person and being  
18 represented by Theodore Herrera, Esq., while EILEEN WALTER  
19 appeared in proper person.

20 Defendants acknowledge that the sum of \$25,000 was borrowed  
21 from W. G. Oliver, and that the note in said amount, at ten per  
22 cent (10%) interest was given therefore on May 18, 1992. It was  
23 admitted by the Defendants that the same was a community debt and  
24 that no payment of principal or interest has ever been made  
25 thereon. EILEEN WALTER agreed that if NORBERT WALTER promptly  
26 paid the debt owed, she would forgo her claim that the debt was  
27 not a community debt and allow the same to be further adjudicated  
28 in the Defendants' divorce action.

1 GOOD CAUSE APPEARING, AND NO ISSUE OF MATERIAL FACT  
2 OUTSTANDING, THE COURT HEREBY ENTERS ITS JUDGMENT for the ESTATE  
3 OF W G OLIVER and against Defendants NORBERT WALTER AND EILEEN  
4 WALTER in the amount of \$25,000 together with interest at the  
5 agreed rate of 10% from the date of May 18, 1992, until paid.

6 THE COURT FURTHER FINDS that the note provides for  
7 reasonable attorney's fees for the collection thereof and court  
8 costs, and hereby awards \$ 3000.00 <sup>20</sup>/<sub>100</sub> as the attorney's fee  
9 and Court costs of \$150.00.
