## THIRD AMENDMENT TO MINING LEASE AND AGREEMENT

This Third Amendment to Mining Lease and Agreement ("Third Amendment") is made effective this 30th day of June, 1999, by and between VEK/ANDRUS AND ASSOCIATES, a Nevada general partnership of Andrus Resources Corporation, a Texas corporation, M. J. Andrus Interests, Inc., a Texas corporation, and VEK Associates, ("VEK/Andrus") and NEWMONT GOLD COMPANY, a Delaware corporation, successor in interest to NEWMONT EXPLORATION LIMITED ("Newmont").

## **RECITALS**

WHEREAS, VEK/Andrus and Newmont have previously entered into a Mining Lease and Agreement dated July 15, 1992, with respect to certain unpatented lode mining claims located in Eureka County, Nevada, a memorandum of which was recorded on August 31, 1992, as Document No. 142089, Book 238, Pages 136 - 148, inclusive, of the Official Records of Eureka County, Nevada; and

WHEREAS, VEK/Andrus and Newmont executed a First Amendment to the Mining Lease and Agreement on September 4, 1994 (the Mining Lease and Agreement, as amended by the First Amendment is hereinafter referred to as the "Agreement"); and

WHEREAS, VEK/Andrus and Newmont executed a Second Amendment to the Mining Lease and Agreement on July 17, 1997 (the Mining Lease and Agreement, as amended by the Second Amendment is hereinafter referred to as the "Agreement"); and

WHEREAS, VEK/Andrus and Newmont desire to again amend the Agreement as set forth in this Third Amendment;

NOW THEREFORE, in consideration of the mutual agreements contained herein, VEK/Andrus and Newmont hereby amend the Agreement as follows:

Section 1 of the Agreement regarding the Property description is hereby amended by deleting Exhibit "A" which covers 342 claims and substituting a revised Exhibit "A" which covers 92 claims. The revised Exhibit "A" is attached to this Third Amendment and made a part of the Agreement.

Section 5 of the Agreement which deals with Advance Royalty Payments is hereby amended by deleting the payments due on July 15, 1999, July 15, 2000, July 15, 2001, July 15, 2002 and each July 15th thereafter and substituting the following payments:
